Pursuant to 20 U.S. Code § 1232h and New Jersey Statute 18A:35-4.20 and New Jersey Statute 18A:35-4.7, my child, _____ may not receive medical or physical examinations unless written consent is provided by me or my spouse, _____.

Pursuant to New Jersey Statute 18A:35-4.20 and New Jersey Statute 18A:35-4.21, I demand that any sex education class, enrichment or other stress the importance of abstinence.

Pursuant to N.J.S.A. 18A:35-4.7, please see the attached letter regarding health, family life education, and sex education that is in conflict with our the sincerely held moral and religious beliefs of our family.

Pursuant to the Every Student Succeeds Act (ESSA), I hereby request time to observe _____ throughout the school day in various classes within the first two weeks of the 2022-2023 school year.

Human Sexuality/CRT /SEL Instruction Parental Non-Consent/ Opt Out 1 2

Form for the _____ School Year

I, _____, as parent and/or legal guardian of _____,

a minor child, hereby exercise my right under the Protection of Pupil Rights Amendment, the U.S. Constitution and the Constitution and laws of the State of New Jersey, to direct the upbringing and educations of my minor child, and hereby place school administrator on notice of the following:

1. I DO NOT CONSENT to my child's participation in ANY instruction, discussion or study on human sexuality, race, gender, identity, LGBT, equity or social emotional learning which is derived in whole or in part from; contains information from; or references to the following sources, including but no limited to:

A. National Sexuality Education Standards

B. Future of Sex Education (FoSE) Initiative

C. Sex, Etc.

D. LGBT

E. GCAPP / FLASH

F. ETR, Inc., HealthSmart, Making A Difference, Draw the Line, etc.

G. Advocates for Youth, 3 R's (Right, Respect, Responsibility)

H. Answer, The Trevor Project

I. SIECUS: Sex Ed for Social Change, PrEP

J. Planned Parenthood (including active videos like Roo, video library)

K. The Human Rights Campaign, The Kinsey Institute

L. GLSEN (Gay Lesbian Straight Education Network)

P. Any SEL/SEEL programs including, but not limited to, BrainPop, Sanford Harmony, Purpose Prep, Second Steps, Edgenuity, RethinkEd, Seven Mindsets, etc.

2. I DO NOT CONSENT to my child being given instruction or information on or being subjected to discussion of any aspect of human sexuality unless I opt-in writing for a sexual risk avoidance / abstinence centered curriculum during Health class. I firmly prohibit the exposure of my child to instruction, videos, or lessons related to the following topics:

A. Abortion;

B. Birth control / Contraceptives

C. Sexual activity of any kid whatsoever, including, but not limited to, vaginal, oral or anal sex;

D. Sexual orientation, including, but no limited to any variant of homosexuality, including but not limited to, lesbian, gay, bisexual, queer, or questioning identities;

E. Transgenderism or gender identity, including, but no limited to, gender as social construct; gender binary; gender spectrum; gender reassignment surgery, gender dysphoria, false gender pronouns, gender expression, or cross-sex hormones;

F. Any referral of my child to a counselor, medical, professional, social worker, within or outside the school for purposes of discussing sexuality, or any of the topics listed herein;

G. Any written material of; reference to; or referral to an outside agency, group, individual or organization relating to sexuality (including, but not limited to those listed in Section 1).

H. Any obscene or harmful to minors materials whether in print or online databases like Galileo, Gale, EBSO, etc.

I. Any reference to or participation in a personal analysis, evaluation or survey that reveals or attempts to affect my child's attitudes, habits, traits, opinions, beliefs or feelings concerning: political affiliations; religious beliefs or practises; mental or psychological conditions; sexual behaviour or attitudes; sexual orientation; gender identity; or illegal, antisocial, self-incriminating or demeaning behavior;

J. Collection of data concerning any characteristics of my child listed in paragraph 2C above, where collected by the school, the strict, any other governmental entity, or a contractor or vendor, and whether or not such data is personally identifiable.

K. Any advertisement of or participation in any group, organization, club, entity or activity that discusses or addresses sexual activity, sexual orientation or gender identity, under the guise of "bullying" or other rationale;

L. Any additional instruction and discussion, including but not limited to: classroom teachers, school staff, third-party providers, YouTube or other videos, films, live streaming, other audio-visual methods, textbooks, workbooks, or handout material, including any entity listed under Section 1 or any topic listed under Section 2.

I am requesting alternative academic instruction for my child during the same period that any instruction on any aspect regarding above is provided or presented. This curriculum conflicts with our conscience, sincerely held moral and religious beliefs. My child shall be excused from these portions of the course(s) and no penalties as to credit or graduation shall result.

I hereby request that this notification be placed in my child's permanent file and be provided to all people offering instruction to my child during the school year. Any instruction contrary to this notice will be the subject of further action to protect my child.
